## TERMS OF REFERENCE FOR AIRCRAFT MAINTENANCE ZS-PBP

---

### 1. Purpose

The KwaZulu–Natal Sharks Board is seeking proposals from suitable and South African Civil Aviation accredited service providers to provide maintenance and general repairs for its 1984 vintage Partenavia P 68 C, registration ZS-PBP.

### 2. Duration of the contract

2.1 The duration of the contract shall run over the period of 36 months starting after signing of the service level agreement with KwaZulu–Natal Sharks Board.

### 3. Scope of work

- 3.1 The appointed service provider would be expected to facilitate general maintenance and repairs to the aircraft including the MPI (Mandatory Periodic Inspection).
- 3.2 Any required spare parts to be sourced by the AMO in consultation with the KZNSB
- 3.3 The aircraft operates out of FAVG (Virginia Airport) and as such bidders ideally should be based at Virginia Airport, be an accredited Aircraft Maintenance Organisation and provide proof of such.
- 3.4 The bidders are expected to have at least five years' experience servicing Partenavia P 68 C series aircraft. The aircraft type must be on their AMO licence and they must have the aircraft type service manuals including all current aircraft directives and bulletins. Proof of such must be provided:

## CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
