DESCRIPTION OF A TENDER

The KwaZulu-Natal Sharks Board Maritime Centre of Excellence (KZNSB) is mandated to be a global leader in bather protection against shark while minimizing environmental impact, thus promoting tourism. With that said, promoting tourism requires KZN Sharks Board to conduct aggressive campaigns and awareness to educate our community and tourists about our services and in addition, to be recognized in the market as a brand. We then saw a need for installation of the advertising billboard to our premises to educate and promote the Sharks Board brand.

Therefore, this tender specification calls for the design, manufacture, supply, install and management of an advertising billboard structure to be erected on KZN Sharks Board premises. It must be noted that, first preference will be given to KZN Sharks Board's campaigns. If no campaigns, then third party advertisements can be permitted on approval by KZN Sharks Board.

The tender is open to any designs and service providers are requested to submit and attach designs for advertising structure on their proposals for evaluation. The successful service provider will therefore pay rental or revenue percentage on monthly basis to KZN Sharks Board. The project is divided to two (2) phases.

PHASE 1

Phase 1 requires a successful service provider to acquire billboard approval/permission to erect from eThekweni Municipality before installation. The following information is required for billboard application: -

1. Submitting design drawings for billboard to be erected.
2. Submit superimposed artwork design.
3. Copy of lease agreement with landlord (KZN Sharks Board).
4. Paying of Council application fee.
5. Motivation letter for billboard.
6. Engineers stability certificate to ensure the stability of the structure.

units and/or advertising as may be reasonably required from time to time during the period of the contract.

- The rights granted herein permit the erection and management of the advertising billboard structure within KZN Sharks Board premises as specified.
- The structure to be designed should be aesthetically pleasing to maintain the architectural integrity of the precinct and also provide KZN Sharks Board information.
- Monthly routine maintenance inspections must be carried out to ensure that the advertising sign/ structure remain in a good state of repair and proper working condition at all times.
- Intermediate maintenance as required must be attended to with minimum delay, with time frames provided for attendance.
- The design shall incorporate every reasonable precaution and provision for the safety of all those concerned in the operation including the safety of the general public and shall be in compliance with all Occupational Health and Safety requirements.
- The maintenance of all signs and/or structures erected in terms of this tender will remain the responsibility of the service provider.
- KZN Sharks Board may call for certification by a Professional Engineer or approved competent person in respect of any structure and/or any advertising sign structural stability and safety.

MANAGEMENT OF THE STRUCTURE

AGREEMENT WITH KWAZULU NATAL SHARKS BOARD

The successful service provider will be obliged to enter into a binding agreement with the KZN Sharks Board on the conditions expressly or by implication embodied in this tender, immediately upon notification to the tenderer of the acceptance of its tender by the Sharks Board. The agreement will come into effect on the date of signature by the CEO of KZN Sharks Board.

TERMS OF PAYMENT

The service provider shall pay KZN Sharks Board monthly rental as agreed by both parties and will escalate annually. KZN Sharks Board has a right to terminate contract for payments not received within 2 (two) months.

EVALUATION

The evaluation of bids shall be based firstly on functionality, then price and BEE in accordance with circular 53 issued by National Treasury on the evaluation of bids: - (80:20). Service providers who could not achieve a minimum quality score (points) of 70%

threshold will not be considered further.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
